1. In the tender invited vide this office tender notice No: NWDA/Tech-II/IWW-2019/04/2019/259-262 dated 08-08-2019, following modifications have been made in the Section – II : Qualification Criteria for far wider search of prospective bidders:

**Clause 7 :** The agency/bidder should be a well established Professional Fabricator and Manager for Exhibition of any Conference/Event/Exhibition and must have an experience of minimum 10 years in the same industry and should have done the same work in a minimum of 15 (Fifteen) Events/ Conferences/ Exhibitions of Govt. of India/Public Sector Undertakings out of which 10 (ten) should have been organized in NDMC areas during the past 10 years.

**Clause 8 :** The agency/bidder should have an experience of at least 15 VVIP/VIP events comprising Conferences, Exhibitions of 2000 sq.m and above, Prime Minister of India /President/ Vice President /Union Cabinet Minister/Chief Minister of State functions, during the last five financial years i.e., 2014-15, 2015-16, 2016-17, 2017-18 and 2018-19 (Attach copy of Work Order/ Completion certificates/ Payment Receipt etc.)

2. The last date of submission of Bids is extended up to 12:00 hrs on 04.09.2019 (Wednesday) and online Tender form availability time will be upto 11:00 hrs on 04.09.2019. Bids will be opened on the same day i.e. on 04.09.2019 at 15:00 Hrs.
